## **Income Eligible Wait List**

Child Care Circuit (CCC) in addition to Mass 211 and all child care programs with state subsidized slots manage the Income Eligible list for Region 3. This is the Massachusetts waitlist for eligible families to access all state subsidy programs. #### **Head Start**

If your child is 3 or 4 years of age and you meet the income guidelines you may qualify for a Head Start program. Contact your nearest Head Start program for more information:

#### **Dependent Care Assistance Program**

Your employer may offer an employer-sponsored benefit plan that allows employees to pay for certain dependent care expenses on a tax-free basis, up to a specified limit. In most cases, DCAPs are funded by employees with pre-tax dollars through payroll deductions.

#### **Child Care Tax Credit**

The child and dependent care credit is a tax credit that may help you pay for the care of eligible children and other dependents (qualifying persons). The credit is calculated based on your income and a percentage of expenses that you incur for the care of qualifying persons to enable you to go to work, look for work, or attend school. #### **Department of Defense**
